## MATTERS ARISING FROM THE MINUTES OF LAST AGM

No matters arose from the minutes of the last AGM, and minutes were accepted as a true record.

#### TREASURER'S REPORT

Malcolm Millard asked if the OCA supported schools overseas. Ceri Jones advised that schools overseas are supported by the School directly, rather than the OCA. For example the longstanding support Caterham School has given our partnership school in Lerang'wa, Tanzania.

Paul Sharp proposed donations for 2022 which were similar to 2021 donations.

#### **ELECTION OF COMMITTEE OFFICERS**

The OCA Vice-President Karin Schulte and Committee Member Emma Gooden both stood down this year. Clive Furness thanked them for their invaluable support.

As there were less nominations this year than Committee positions that were available, all nominees were appointed.

Clive Furness was nominated as President for one more year in order to ensure a smooth handover to the Vice-President who is new to the Committee.

David Kinnear (OC 1985-1988) was nominated for the post of Vice-President.

Benjamin Horne (OC 2002-209) and Rhia Patel (OC 2011-2016) were both nominated as Committee Members.

### OCA CONSTITUTION REVIEW

Clive Furness thanked the OCA Committee for all their input regarding the review which was a timeconsuming and robust process. He explained that the OCA had felt compelled to amend the constitution as it had been an unincorporated corporation which had left the Committee and the Association open to certain risks. He thanked the School in their support with information for the process. Clive Furness ran through the key changes in the revised constitution. It was emphasised that although, going forward, the OCA bank account will be run by the School, it will be a restricted fund solely for the OCA, and the OCA Treasurer will oversee this fund.

The reviewed constitution was approved unanimously by those in attendance of the AGM, the motion was carried and the new constitution will be in place as of immediate effect with regards to governance. As the School auditors will audit the accounts going forward, the audit will fall in line with the School financial year starting in September.
