Mary Whenman highlighted one benefit to younger OCs in joining the committee is the opportunity to gain real experience of non-executive roles. Paul Sharp suggested that we ask OCs who have completed their term on the Shadow Board.

ANY OTHER BUSINESS

Graeme Mew enquired if another Annual Dinner was in the planning. Clive advised the last few years indicated that the events that are most popular amongst OCs, those that have 'sold out' are professional networking evenings, the more informal pub events and those back at school. Previous Annual Dinners in London have been a hard sell to OCs involving a lot of work from the school to encourage attendees. It was mooted that perhaps a more formal dinner should be hosted less regularly, for example every 5-10 years, as a special occasion.

Clive Furness thanked each member of the committee for their contribution and support during his Presidency.

Ceri Jones thanked Clive Furness for his extended service to the OCA as President for the last five years and remarked upon the improvements he has made to the OCA.
